

## *New Members Elected*

BETHESDA — The National Council on Radiation Protection and Measurements (NCRP) elected seven new members and seven returning members to Council. The election results were reported at the 50th NCRP Annual Business Meeting on March 11, which was held in conjunction with the 2014 NCRP Annual Meeting on the topic of *NCRP: Achievements of the Past 50 Years and Addressing the Needs of the Future*.

NCRP was chartered by Congress in 1964 under Public Law 88-376 to serve as a nonprofit organization that represents a national resource on topics related to radiation protection and radiation quantities, units and measurements. NCRP's mission is to formulate and widely disseminate information, guidance and recommendations on radiation protection and measurements which represent the consensus of leading scientific thinking. The Council's mission also encompasses the responsibility to facilitate and stimulate cooperation among organizations concerned with the scientific and related aspects of radiation protection and measurements.

There are 100 elected members of the Council, who are recognized as leaders in many scientific fields of relevance to radiation protection and measurements in medicine, homeland security, environmental protection, nuclear technology, and public and occupational radiation exposures.
